Competence assessment changes for CIfA applications – sign up to our Professional Pathways bulletins to learn more

Previously we have told you about the changes we are making to the way we assess applications for CIfA accreditation which will be implemented next year with a target date of April 2022. These include changes to the **criteria** we assess applications against for Practitioner, Associate and Member accredited grades as well as the introduction of a **professional review** for Member applications.



To demonstrate competence against the new criteria, applicants will need to demonstrate that they understand and work in accordance with the Code of conduct and relevant CIfA Standards. More details are in the newsitem, and for a sneak preview of the new competence matrix, please click here.

CIfA staff are working with the Advisory Council and Special Interest Groups to develop supporting guidance and resources to support the new process and we are planning a series of ethics and accreditation workshops for applicants in the New Year.

If you are thinking about upgrading your accreditation after April next year, we recommend signing up to our Professional pathways bulletins so you will have access to more information about the new assessment process and the resources available to support you with your application over the coming months. Our **professional pathways** scheme provides structured resources to support members throughout their careers and to help them understand and meet the competence requirements for professional accreditation at the appropriate grade.

New project Toolkit for finds reporting: Roman coinage

This Historic England funded project will produce a Toolkit for Finds Reporting: Roman Coinage, endorsed by CIfA and Historic England (HE), to provide guidance for the Historic Environment sector to ensure reliable and consistent reporting and analysis of Roman coins.



It is a direct progression from the new CIfA/HE initiative <u>Toolkit for</u>
<u>Specialist Reporting</u>, which provides a widely recognised aid to planning, writing, and monitoring finds reporting. The Toolkit for Finds Reporting: Roman Coinage will be hosted on the CIfA website and is aimed at a wide

audience, including coin specialists, project managers, planning/monitoring archaeologists and archive archaeologists. It is envisaged that this Toolkit will be used to support the training of new coin specialists, as well as by students/apprentices, local societies and community groups, and all others engaged in producing Roman coin reports. The project is due to complete, and the Toolkit launched next summer.

How can individuals, organisations and processes adapt to be more sustainable and release less carbon?


The UK currently ranks in the top 20 CO2-emitting countries. As governments and experts begin to address their future targets for cutting carbon emissions, archaeology – like all disciplines – needs to think about changing its working practices to contribute to net-zero targets.

In recognition of this challenge, last year a small group of CIfA members formed a Climate Change working group reporting to CIfA's Advisory Council. One of the first actions of the working group has been to develop a Carbon Reduction Guide Table, looking at how CIfA and the wider sector can reduce their impact on the environment and respond to the climate, while working within the Institute's Code of conduct and Standards and guidance.

We have upgraded the CIfA website <u>application pages</u> to include all guidance in one place which should make it easier to apply and you can <u>apply online</u> too, which is much quicker.

If you successfully apply or upgrade and pay your <u>subscription fee</u> you can be listed in the new online <u>Directory of Accredited Professionals</u>. This is available to over 5000 contacts and is a useful tool to make professionals in the Historic Environment sector more accessible to other professionals and the public.

CSCS PQP card and CIfA professional accreditation

If you are professionally accredited with CIfA (PCIfA, ACIfA, MCIfA) you can use this to apply for a Professionally Qualified Person (PQP) CSCS card. The card lasts for five years, although because its validity is reliant on your professional accreditation, it is important to ensure that your CIfA membership remains current so that you are entitled to hold the PQP card if you have used your CIfA accreditation to obtain it.

If you need a CSCS to access sites you will need to apply to CSCS for a different type of card. You can find information about different types of card on the <u>CSCS website</u> (type archaeologist into the Card Finder) and you will find more <u>CSCS information and FAQs</u> here.
