# **Equality and diversity in archaeology: update from CIfA's Equality and Diversity Steering Group**

Since July 2020, a small Equality and Diversity Group Steering Group has been taking forward an initial set of priorities for equality, diversity and inclusion relevant to CIfA, which had been developed from a report prepared by Advisory Council, and building on the CIfA, FAME and Prospect joint statement setting out their commitment to tackling bullying, harassment and discrimination in archaeology. **Read more here** 

One of the priority areas is to provide relevant training events and to encourage greater use of employers' internal procedures. Next week (2 **February**) we are running a training session with Protect (the whistleblowing charity). It is aimed at upskilling staff within archaeological organisations to encourage a speak up culture, handling concerns and how to address grievances, to create happy workplaces and mitigate risk. # **COVID-19: Updated guidance on Site Safety from Prospect**

CIfA remains determined to ensure that archaeological work does not pose a threat to the safety and well-being of archaeologists and their families, other workers or the wider public during the Coronavirus crisis. Doing so will help to reduce pressure on health services and save lives.

We wish to note, however, the heightened concern in relation to the impact of increased transmissibility of new COVID-19 strains and high infection rates on workers unable to work from home during the latest national lockdown. We would like to reiterate our support for **Prospect's guidance for archaeologists** working on construction sites (which was revised on 20 January) which seeks to mitigate the union's concerns and promote a safe working environment.

**The updated guidance** re-emphasises the need for 2m social distancing (previously relaxed to 1m+), and face coverings whilst indoors unless exempt. Companies are also asked to be mindful of the type of activities taking place, and refrain from undertaking high risk activities that could result in the need for emergency services. As part of these mitigations companies are being asked to consider enabling symptom-free testing to staff, either by providing testing themselves, or supporting staff attending local authority rapid testing where eligible.

CIfA intends to update its formal endorsement of the Prospect guidance in the near future and will be supporting its use for the development of workplace agreements (between employers and trade unions) and / or as supporting text in the continued use and updating of local Site Operating Procedures across the sector.

### Planning advocacy update

Last year CIfA responded to various consultations on English planning reform, including reforms relating to the Planning for the Future white paper, and several other consultations relating to more immediate changes to the planning system.

Progress on the white paper is continuing within MHCLG, and CIfA recently held a meeting with advisors from the membership and other archaeological organisations to develop proposals for how archaeology could work in the proposed new system. A briefing which explores new consent mechanisms for 'growth areas' has been sent to MHCLG.

CIfA will also be responding this week to a consultation on expanding permitted development rights in England. In recent years there has been a string of successive changes which remove the need to apply for planning permission for ever more types of development, at ever greater scales. CIfA believes that these changes are undermining the management and protection of the historic environment provided by the National Planning Policy Framework (NPPF) and, as a result, producing unsustainable development.

This is why CIfA recently joined 18 other bodies from across the built, natural, and historic environment sectors in signing a letter to call on the Government in Westminster to rethink its approach to permitted development rights in England. CIfA is also developing a response to the latest stage of Scotland's ongoing process to develop a new fourth National Planning Framework. The new Framework is expected to subsume existing Scottish Planning Policy. CIfA supports the principles set out in the recent **position statement**, which incorporate heritage in an extremely positive and progressive way, but will be pressing Government for details on how the revised structure for policy and guidance could end up squeezing important existing guidance for archaeology.

# The Social Distancing for Archaeology Toolkit (SoDA)

In an effort to mitigate the effects of COVID-19 on the archaeological sector, L - P: Archaeology was awarded a grant by the <u>Historic England Emergency COVID-19 Fund</u> to produce a 'toolkit' of resources to help

demonstrate social distancing guidance in archaeological field and postexcavation work. The Social Distancing for Archaeology Toolkit (SoDA) project builds on the vital work of Prospect Union (Archaeologists **Branch)** who have been working to produce guidance during the rapidly changing state of archaeological fieldwork in early 2020. Liaising with stakeholders in the UK Archaeology Industry Working Group (including representatives from CIfA, FAME and Prospect), SoDA has sought to complement this work by producing high impact, freely available resources that demonstrate this guidance in practice. The project has produced a series of short videos in different on-/off-site work scenarios, as well as signs, stickers, a toolbox talk and a risk assessment workflow. These resources were produced with the support of Prospect, who provided input and guidance during this project. The project hopes that these resources can be re-purposed in different archaeological contexts that extend beyond the commercial sector, including community digs and academic field schools.
