The changes reflect the preliminary stages of a much larger rewrite/revision project that will see a formal relaunch of the document. The changes made to the current version are relatively minor with the primary content remaining largely unchanged but with the removal of out-of-date references and some reformatting.

The Industry working group was originally set up to look at pay across the sector but has since evolved to become a forum for wider discussion, with a remit to collect and share information about matters affecting the industry. Originally formed from representatives of CIfA, FAME and Prospect members now include ALGAO, BAJR, Prospect Archaeology Branch and CIfA Diggers' Forum.

Regular agenda items include the stability of the market and the setting of minimum salary recommendations by CIfA. Other matters that have been discussed are construction site access for archaeologists, training opportunities for early career archaeologists, diversifying the profession and equality, bullying and harassment.

New specialist competence matrices

With the help of our Special Interest Groups, we are pleased to announce three new specialist competence matrices for academia and research, environmental, and local authority, HER and Development Control officers on our <u>matrices</u> page.

The matricies demonstrate how the application criteria could be applied to different specialisms and areas of expertise and also to assist the Validation committee when making a decision.

Applying or upgrading?

You can now <u>apply online</u>! You can write your application details directly into an online form or attach Word/Pdf documents. Guidance for applying includes the <u>Application Guide</u> and <u>Specialist competence matrices</u>.

Plus, we have the <u>Pathways guidance</u> to assist those applying at Practitioner (PCIfA) grade and the <u>BAJR guidance</u> to assist fieldworkers applying to Practitioner (PCIfA).

It is especially important to leave enough time to apply for Practitioner (PCIfA) grade, if you or your staff need a CSCS card or to renew it. These can be processed and assessed within 2 weeks if the references are returned promptly, but you should allow up to a maximum of 8 weeks.

You can send in Practitioner (PCIfA) applications **anytime** and they will be assessed as soon as possible, when all the information is received. For Associate (ACIfA) and Member (MCIfA) applications, the next receipt of application date for the 10 September Validation committee meeting is **Monday 19 August.**
