CIfA news

Advocacy update

COVID-19

CIfA is continuing to advocate on behalf of the archaeology sector and help inform UK governments of the impacts of the pandemic in archaeology. In England, CIfA is sitting on both Historic Environment Forum task groups which are looking at COVID-19 (one focussed on short term recovery, the other on longer term rebuilding). In Scotland, CIfA is sitting on the COVID Historic Environment Resilience Forum. We are also receiving regular updates from Cadw and the Historic Environment Division on processes for managing COVID impact on archaeology in Wales and Northern Ireland.

CIfA has also been advising on new DCMS guidance for the heritage sector which will be published in the coming days. Throughout the pandemic we have been working closely with Prospect to help support the development

of site safety guidance. More information can be found on our **Coronavirus information pages.**

We are currently surveying archaeological organisations and individuals to help inform our contributions to these forums. **You can complete the survey here**.

Planning

The Westminster Government has recently made statements about its aspirations for reform of the planning process, in part to help stimulate economic recovery from COVID-19. This should serve as a taster for what is expected from the English Planning White Paper, which is due to be published by Government very soon. Other press reports have indicated that the Government may be considering major reforms.

We will also be responding to the publication of a radical paper from the Policy Exchange think tank which advocated for the massive scaling back the planning system.

CIfA remains extremely concerned by the Government's insistence that cutting regulation will speed up the planning process and make it more efficient. CIfA has a briefing paper detailing it's policy position on the relaxation of planning control which you can <u>read here</u>. Last year CIfA also conducted the <u>Planning Case Studies Project</u> which developed a body of evidence which showed how the current planning system functions well to protect heritage and prove that it does not create unnecessary burdens, and conversely, highlighting the potential for harm where these systems are undermined.

CIfA recently responded to an initial call for evidence on Scotland's National Planning Framework 4 and will also be participating in this major reform process as they develop later this year.

UK Shortage Occupation List

A current consultation from the Migration Advisory Committee (MAC) is reviewing the Shortage Occupation List (SOL) in the light of propped changes to the UK Government's immigration policy. Archaeology was added to the SOL last year following a previous review and the MAC is not currently re-considering that inclusion. As such all archaeological jobs will be remaining on the shortage list for the until such time as the next full review takes place.

Archaeology and public benefit UKRI Future Leader Fellowship

CIfA are partners on a UKRI-funded research project led by Sadie Watson at MOLA. The project is intended to investigate our sector's approach to providing public benefit from our work, with the eventual aim of producing Policy papers and project design guidance to ensure public benefit is at the heart of all archaeological projects. CIfA's support is particularly valuable

as we acknowledge that archaeology's contribution to society is not particularly well articulated but is a central tenet of our professional practice.

The project will involve detailed reviews of current practice, extensive surveys of both our sector and the public, and close consideration of how the construction and archaeological sectors operate together to establish if we can better navigate the procurement and design stages of large infrastructure projects. First archaeology apprenticeship offered!

We were really pleased to see the first advert for a Trailblazer apprenticeship in archaeology out this week from L-P Archaeology, <u>see</u> <u>advert here</u>. The apprenticeship is an Archaeological Specialist Level 7 degree apprenticeship and is in post-excavation skills with a focus on medieval pottery. The apprentice will gain valuable workplace skills over a three year period as well as a Masters degree in Professional Practice.

The Trailblazer apprenticeships are the culmination of over seven years hard work by the Historic Environment Trailblazer Group of employers and training providers, convened by Historic England and supported by CIfA, Icon and IHBC. The Archaeological Specialist apprenticeship was designed to address skills needs across a number of specialist areas and has benefitted from consultation with relevant CIfA Special Interest Groups.

Updates to the Standards and guidance

Changes were recently made to the wording of the text of the **Standard** for evaluations and watching briefs and the text of the **guidance** sections for archives and archaeological advice – **see here for a recap**. These updates stem from projects that have focused on archaeological archives and archaeological reporting with the collective objective to improve industry standards and provide good practice guidance related to archiving, digital data management and grey literature reporting. The CIfA **Standards** (the paragraph at the top of each document) are binding on all accredited members and Registered Organisations. The **guidance** provides good practice advice outlining how to achieve the **Standard**, it is not binding per se but members and Registered Organisations need to demonstrate that the **Standard** is being achieved and are recommended to document alternative approaches and the reasoning behind them.

Recent changes

In relation to the recent changes, especially those affecting the guidance sections of the Standard and guidance for the creation, compilation, transfer and deposition of archaeological archives and the Standard and guidance for archaeological advice by historic environment services, members and organisations are advised to make use of the resources that have been developed to aid implementation of the changes. These specifically focus on having in place **project-specific selection**

strategies and Data Management Plans. There is no requirement to follow the template examples and proforma provided, they are there to help and support you to make changes where necessary and helpful.


Yearbook survey responses

U.S. Heritage Compliance (CRM) Sector Contracts in 2019 - HBI Releases its 2020 Annual Industry Size Report

TUCSON, AZ – The United States' heritage compliance sector contracted in 2019 by about 10 million dollars. This contraction marks the ninth year in a row of negative growth for the sector since its historic high in 2011. The compliance sector of the heritage industry includes work performed by heritage and environmental firms to achieve compliance with environmental and cultural resource requirements. It is sometimes referred to as the Cultural Resource Management or CRM industry.

These figures come from the just released 2020 edition of the annual industry size report published by Heritage Business International. The report contains a preface on COVID-19, key sector-size statistics, a breakdown of size by U.S. geographic region, historical graphs, and a data table of nominal and real size in dollars and percent annual change going back to 1971. This year's report includes a new breakdown of size by client industry and key notes throughout the report to assist readers in understanding these data. The report is available for purchase and download from heritagebusiness.org.

Dr. Christopher Dore, the report's principal author, added that "While 2019 only showed a small decrease in size, the nine-year negative trajectory of the sector is of concern. Since 2011 the sector has lost 22.8 percent of its value. This is both the longest and largest decline in the industry's history."

Heritage Business International is an L3C social enterprise venture dedicated to helping heritage organizations increase their value, sustainability, and impact. The HBI annual industry size report has been published since 2015.
