CIfA news

Who's CIfA? Where's CIfA?

CIfA is its members, not just the Board and its Advisory Council and staff: those c 4000 members and 80 registered organisations are based in c 39 countries. They are bound by the Code of conduct and accountable to CIfA for their actions wherever they practise. Therefore CIfA is international.

A recent Advisory Council meeting recognised that there were some misunderstandings about CIfA's constitutional and practical remit, and how the Board envisages helping archaeologists outside the UK who seek CIfA support. In parallel with its evolving strategic plan for 2020-30, the Board has published a **statement on Supporting a Global Profession**.

Promoting CIfA accredited professionals to the client sector

A large part of CIfA's external relations work involves providing information about professional archaeology to those that commission archaeological work. We emphasise the need for early engagement, and urge all clients to recognise the importance of commissioning Registered Organisations and CIfA-accredited individuals. Our mantra is 'using accredited archaeologists assures clients that the work will meet their needs and the needs of the public'.

CIfA staff don't have the access to individual clients in the way the Registered Organisations and others do – so please remember to direct them to the <u>Client Guide</u>. It is easier for us to engage with relevant professional bodies and trade associations in the client sector. Recently we have been working for you with The Civil Engineering Contractors Association (CECA), which represents companies who deliver, upgrade and maintain the UK's infrastructure. We have provided Association members with some <u>tips on archaeology</u>.

In parallel, in a consortium with MOLA and Taryn Nixon Heritage Works, we are updating the *Managing archaeology in construction guide* for the Construction Industry Research and Information Association (**CIRIA**). CIfA-accredited professionals are generously assisting us with the advice, insights and case studies through the project steering group. The updated guide will be available next year.

Planning for the Future reforms (England)

As reported in the previous e-bulletin, CIfA is engaged with planning reform issues in England following the publication of a Government white paper in August. CIfA has been undertaking a range of action to raise the profile of archaeological concerns and develop solutions to influence the direction that reform ultimately takes.

In recent weeks we have:

- Published an <u>initial response</u> to the white paper
- Written to the Prime Minister, Chancellor, and Secretary of State for Housing, Communities and Local Government

- Submitted <u>a response</u> to the 'Current changes to the planning system' consultation
- Briefed MHCLG and DCMS on archaeological concerns (<u>briefing for members available here</u>)
- Met with senior DCMS civil servants to discuss the proposals
- Met with and briefed All-Party Parliamentary Archaeology Group members
- Liaised with and briefed individual MPs ahead of a Parliamentary debate
- Attended a roundtable discussion with the Secretary of State Robert Jenrick
- Attended a meeting of the Heritage Council with DCMS and MHCLG ministers
- Been invited to brief the APPG on Housing and Planning
- Been invited to meet with MHCLG civil servants to discuss detailed solutions and policy development.
- Met regularly with Historic Environment Forum members &
- Liaised closely with Historic England and the Heritage Alliance Spatial Planning Advocacy Group
- Worked closely with CBA, ALGAO, FAME and other archaeology sector colleagues
- Taken part in a joint advocacy campaign led by CPRE The Countryside Charity
- Regularly attended meetings of the Wildlife and Countryside Link Land Use Planning Group, representing CBA
- Delivered CPD sessions for members (<u>recording available here</u>)
- Taken part in a UCL workshop discussing the reforms
- Arranged a seminar for RTPI members discussing planning reforms and archaeology

We have secured numerous assurances from Government that it is not the intention to weaken heritage protections and that 'archaeological survey' will continue to be part of the new planning system. We are working to develop these promises into tangible policy outcomes.

CIfA is also keen to ensure that we take advantage of the opportunities which the white paper presents to improve the public benefit that archaeology delivers through its contribution to the planning system. For example, by improving available baseline data on archaeology, putting HERs on a statutory footing, and adopting more strategic approaches to archaeological assessment and mitigation.

The white paper consultation closes on 29 October, and a HCLG Committee Inquiry closes on 30 October. CIfA will be responding to both and welcomes member input.

COVID-19 planning system changes and the historic environment - RTPI seminars Part 1 and Part 2

Government is introducing a number of planning system changes, including legislation and guidance, as a result of COVID-19. The aim is the support business and developers through the current situation and beyond. And, there are potentially more changes on the way as part of the wider COVID-19 recovery strategy.

This two-part webinar delves into the detail of the planning system changes in the context of any impact on the historic environment.

In Part 1, each speaker will set out their interpretation of what the impacts may be. We will hear from a leading historic environment professional body, a major heritage conservation charity and custodian of historic assets, and from an architect and developer with wide-ranging experience of working on projects involving historic buildings and sites.

In Part 2, the speakers will discuss what protections remain in place, any unintended consequences for the historic environment and the strategies and approaches needed to ensure protections, whilst supporting the overall goal.

CIfA and UAUK announce Queens University Belfast degree pathway to receive accreditation

CIfA and University Archaeology UK (UAUK) have announced that Queen's University Belfast is the first university outside England to receive accreditation for a degree pathway. Accreditation recognises undergraduate and masters degrees that provide skills relevant to a career in the historic environment. Queen's University Belfast joins the universities already offering accredited programmes

Further applications are currently being assessed and newly accredited programmes will be announced in due course. The next application deadline is 1 December 2020, **see here** for details.

Students in England and Northern Ireland now have the opportunity to choose a degree programme that will support them to develop a career in the historic environment.

The accreditation was developed to provide a career route for the historic environment as well as fostering strong relations between industry and academia.

Standard and guidance update

The current suite of Standard and guidance documents have been edited with minor changes made to the format. This means that the numbering in some cases has been amended. The updated versions can be **found here**. Please do check that you are referring to the most recent versions.

Reimagining the CIfA Standards and guidance

An extensive review of the CIfA Standards and guidance (content, design, format, usability, and accessibility) is currently underway with a new look set of documents available later next year. The newly established CIfA Professional Standards Advisory Panel (PSAP) met for the first-time in August to get the project underway. The panel is made up of accredited professionals from across the UK and Republic of Ireland representing a variety of different organisations and roles/specialisms. The panel will provide their experience, expertise, and counsel to help support the work undertaken by CIfA staff members, in addition to supplementing the advice and feedback already received from the CIfA Special Interest Groups.

There will be an opportunity to have your say about any proposed changes to content over the next few months as the project progresses.

The aim of the review is to look in more detail at the structure, format, and content of the Standards and guidance and their relationship to the Code of conduct. Redesigning them as a digital resource will be explored to facilitate wider use and better cross-referencing with other resources and good practice examples. This resulting suite of Standards and guidance will ensure that the information presented is:

- Up to date with current practice
- Relevant beyond the UK
- User friendly and accessible
- Presented clearly with easy reference to good practice guidance examples, resources and case studies
- Easier to maintain and update

Registered Organisation Update



There are currently 81 Registered Organisations in the scheme. This will reduce to 80 as Registered Organisation Wardell Armstrong, a multi-disciplinary environmental, engineering and mining consultancy, has acquired the business and assets of Archaeological Solutions Ltd who are also a Registered Organisation. In November, we will be conducting our first online inspections having received applications from two organisations wishing to join the scheme. This will be an opportunity to develop aspects of the inspection process which we may take forward into the future and which may provide an opportunity for more members of staff, particularly in the field, to talk to panel members and contribute to the inspection process.

CSCS update

If you are accredited with CIfA you can use your accreditation to apply for a Professionally Qualified Person (PQP) CSCS card. The card lasts for five years and its validity depends on your professional accreditation, so it is important to make sure that your CIfA membership is up to date during that time. If you are no longer accredited with CIfA it is likely that your PQP card will be cancelled.

The Social Distancing for Archaeology Toolkit (SoDA)

In an effort to mitigate the effects of COVID-19 on the archaeological sector, L - P: Archaeology was awarded a grant by the Historic England **Emergency COVID-19 Fund** to produce a 'toolkit' of resources to help demonstrate social distancing guidance in archaeological field and postexcavation work. The Social Distancing for Archaeology Toolkit (SoDA) project builds on the vital work of Prospect Union (Archaeologists **Branch**) who have been working to produce guidance during the rapidly changing state of archaeological fieldwork in early 2020. Liaising with stakeholders in the UK Archaeology Industry Working Group (including representatives from CIfA, FAME and Prospect), SoDA has sought to complement this work by producing high impact, freely available resources that demonstrate this guidance in practice. The project has produced a series of short videos in different on-/off-site work scenarios, as well as signs, stickers, a toolbox talk and a risk assessment workflow. These resources were produced with the support of Prospect, who provided input and guidance during this project. The project hopes that these resources can be re-purposed in different archaeological contexts that extend beyond the commercial sector, including community digs and academic field schools.
