Memorandum of Understanding between CIfA and FAME

CIfA recently signed a Memorandum of Understanding (MoU) with the Federation of Archaeological Managers and Employers (FAME), and it may be useful to explain a little more about it.

Over the years CIfA has signed MoUs with organisations within the heritage sector to facilitate better collaborative working, and build new and stronger partnerships for influence with our sector and others, in line with our strategic plan strategy – take a look at the <u>Partnerships page on our website</u>. These MoUs enable CIfA to promote our shared interests with these organisations and build better and more productive working relationships to help address issues and concerns that affect all parts of our industry.



Although CIfA and FAME have different perspectives, both are invested in ensuring a healthy and sustainable future for archaeology, promoting a discipline that is recognised for giving value to the public and clients. It's only through cooperation and communication that we can hope to achieve this.

The Memorandum of Understanding between CIfA and FAME aims to begin the process of building a better and more productive relationship between archaeology's professional institute and trade association. It formalises the basis for collaboration between the two organisations, complementing our long-standing positive working relationship with the Prospect trade union. This MoU was formulated over a period of months at Board level, as with all of CIfA's other MoUs.

MoUs are formal but non-legally-binding statements of intent that seek to foster a collaborative working relationship by helping the two organisations understand each other, by setting out the established relative remits of the organisations and identifying areas of potential collaboration. They can be valuable in helping others understand the organisations' legitimate similarities and differences of roles and perspectives.

Dig Digital Toolkit update



Joint Statement from the Archaeological Archives Forum

The Archaeological Archives Forum has issued a joint statement highlighting how all heritage professionals can support the effective management of digital data in archaeological projects.

The Dig Digital project, an initiative of the Forum funded by Historic England and delivered by DigVentures in partnership with ClfA, has created guidance targeting those who deal with digital data in archaeological projects. The project is designed to address an inconsistent and unsustainable approach to digital data for archaeological projects and archives identified by the Future for Archaeological Archives Programme, formed by Historic England and Arts Council England.

Even though we are always looking for accredited members at any grade (PCIfA, ACIfA, MCIfA) to get involved, we particularly need new Validation committee members this year as 4 committee members have had to step down after serving their two 3-year terms.

Validation committee role - to carry out a peer review process to assess individual applications against the requirements for CIfA accreditation for both ethical and technical competence using the competence matrix and a scoring system. Meetings are held virtually with one in person each year.

Panel member role - to assess individual applications against the requirements for CIfA accreditation for ethical competence in an interview discussion format and report to the Validation committee.

Specialist assessor role – to assess individual applications examples of work from different specialisms against the requirements for CIfA accreditation for technical competence, where we are lacking expertise on Validation committee, and report to them.

CIfA's assessment service update



CIfA has been delivering an assessment service for NVQs for approximately 16 years. These practical, skills-focused qualifications are based on employer-led standards and have been used to train and accredit a wide variety of archaeologists. They are a great way to provide a much-needed alternative route into the industry, as well as helping current archaeologists develop their skills and have their competence recognised. As these are formal qualifications that appear on the Regulated Qualifications Framework, they fall under the auspices of the qualifications regulator, Ofqual.

More recently, CIfA's assessment service for qualifications has been recognised by Ofqual to deliver end-point assessment for apprentices in the industry. These qualifications also provide a valuable alternative route into the sector. In addition, they are a great way for organisations to expand their workforce while having a professional partner that delivers formal, industry-approved training and development. Like NVQs, these qualifications are also based on standards that have been designed by employers in the industry, and like NVQs, they're regulated by Ofqual.

To promote the qualifications assessment service, we need a clear identity and brand that is instantly recognisable by CIfA's various audiences, which includes the archaeology industry, qualification candidates, training providers and, of course, the regulator, Ofqual.

Therefore, CIfA is naming its assessment service for qualifications CIfA Qualifications, recognisable by the logo above. CIfA believes that this better reflects the nature of the qualifications assessment service that it provides and also allows scope to encompass any future qualifications offer.

CIfA and IAI - informing climate change responses the role of archaeology

Thursday 9 November 2023, 1pm-2pm, online

Archaeologists spend their lives studying past societies and their environments and are uniquely placed to help us understand and adapt to environmental changes in the future as a result of the climate emergency. Drawing on case studies from the built and natural environments, this CPD session will focus on ensuring that responses to climate change are informed by an understanding of the historic environment, how it has evolved and how it might be impacted in the future.

Case study 1 – adaption and reuse of urban early buildings

Cóilín Ó Drisceoil, National Monuments Service

Employing case studies from the medieval town of Kilkenny, the talk will highlight some of the benefits and challenges that arise for archaeology from the adaptation and reuse of urban early buildings. Experience demonstrates that the proactive integration of archaeological investigations, and particularly buildings archaeology methods, into such projects reveals new knowledge about the origins, development and changing forms and uses of early buildings. This knowledge is vital for informing the architectural, conservation and engineering designs of adaptations but also adds greatly to their overall cultural value by providing historical integrity and authenticity. Proactive and ongoing iterative archaeological investigation is essential for resolving the tensions that can arise between the needs of archaeology and the practicalities of modern interventions in historic buildings.

Kara Ward and Vicky Ginn, Historic Environment Division

Kara will give an introduction to peatland restoration and its role in meeting climate change targets. She will also discuss the value of peatland archaeology, threats to peat and peatland archaeology, the NI Peatland Strategy and its context and future considerations for the restoration of peatlands. The case studies that Vicky will present give a brief overview of some of the issues facing exposed archaeology within peatscapes, and examine how these issues may be addressed.

The speakers

Kara Ward and Vicky Ginn are archaeologists with the Department for Communities' Historic Environment Division in Northern Ireland. They have a particular interest in environmental archaeology and conservation.

Cóilín Ó Drisceoil is an archaeologist with the National Monuments Service. He has a particular interest in the archaeology of early buildings and gardens and has undertaken excavations and buildings archaeology investigations on many of Kilkenny's key medieval and early modern buildings.
