- Funded through the HES Archaeology Programme, this has resulted in (for 2.5 days a week, filled by Cara Jones) and 4 CPD training workshops.
   Financial support for a ClfA post (Cara Jones) on a full-time basis from April 2020.
- CPD courses delivered in the period included:
  - "Embedding Workplace Training" which took place in October 2019 in Edinburgh,
  - "What's going wrong with desk-based assessments?", 15th October 2019, Edinburgh City Chambers;
  - "The practical application of dendrochronology in Scottish archaeology, buildings and landscapes" Dalkeith Corn Exchange, 12th November 2019;
  - o "ClfA accreditation: a step-by-step guide" held on the 27th March 2020
  - "Scottish group: Introduction to standards and guidance" web-based workshop held on 30th July 2020.

These workshops were attended by 85 members

- ClfA also supported "Re-imagining Scottish Archaeology: structures, delivery and funding", a series of workshops organised alongside ALGAO Scotland and FAME, in Inverness, Edinburgh and Glasgow (November and December 2019).
- Committee remains interested in widening and deepening our committee membership, in particularly looking to tie in closer with ALGAO: Scotland members and with Scottish archaeologists based outwith the Central Belt.
- We continue to engage with CIfA Advisory Council and Groups Forum.
- Members of the committee contribute to ClfA consultation responses to Scottish Government public consultations.
- We collate and contribute to a Scottish Group newsletter that is emailed to members on a quarterly basis.
- Social media:
  - We have active CIfA Scotland Facebook and Twitter (@CIfA\_Scottish) accounts that we use to engage with our members, promote relevant Scottish heritage news, and to crosspromote CPD training opportunities.

## 6. Treasurer's report (Tristan Boyle)

Very few expenditures in the year due to travel restrictions imposed by COVID-19. We requested £800 total from CIA HQ, but all activities have been undertaken remotely via ZOOM, Skype or similar, and therefore there have been no outgoings. We anticipate additional income from two subscriptions by non-CIfA members who pay £10 per year.

The SGClfA budget is used to cover travel costs to represent the committee, e.g. at ClfA Groups Forum events. It can also be used for room bookings for committee meetings, training events etc.

 Query from Coralie: what proportion of ClfA members based in Scotland are members of the ClfA Scottish Group?

Answer from Megan: members have automatic opt-in to an area group based on address when they join ClfA, but can choose to opt out. Cara – also other members can choose to opt in irrespective of their geographical basis.

• Coralie – what is the total CIfA membership?

Megan - Taken from the 2020 Annual Review: Current membership statistics: Membership of CIfA now stands at 3931 (21 July 2020). Of these members, 3033 are accredited professionals Member, Associate and Practitioner) who have demonstrated their technical competence and ethical suitability – including the professional skills relevant to their grade of accreditation – to the Validation committee

- John L what is the total size of the workforce in Scotland? We don't have precise numbers on the total archaeological workforce in Scotland, but there ensued a general discussion about the total number of SGCIfA members being a relatively high proportion of the total CIfA membership (544 SGCIfA members out of 3931 total CIfA members 14%)
  - John L should we try to be increasing overall members of CIfA members as a proportion of the workforce?

Cara - target groups – students, also looking to run application workshops. These couldn't be undertaken after the COVID-19 lockdown, but we have the means to do them virtually. Joe – also looking to branch out from the current Central Belt bias. We don't have figures to hand, but the feedback in the past has been that CIfA is not seen as relevant or offering much to archaeologists outside the Central Belt.

• Coralie – are we missing many? Are there many members of the profession in Scotland who are not already members?

Cara – good level of membership within contracting and consultancy. Need better levels in smaller sub-sectors

John – not 100% membership of CIfA within ALGAO

Lindsey – looking to raise profile and membership of ClfA within academia.

Tristan – competition to write an essay as a student drew him into ClfA and the committee back in 2016-7.

- Lindsey query on number of members should be 544.
- Kevin good to see increase in number of student affiliate members in latest issue of *The Archaeologist*. CSCS card has increased membership – successful. £10 to join ClfA SG could be attractive.
- David 11,000 BAJR members, 1,000 engagers currently. Question "what does ClfA do for me?" Need to reach out and make ClfA really powerful in



Scotland. Increased use of social media. Good 3-year plan to build on. Want people to want to engage, rather than because they have to.
