### Everyday ethical dilemmas

In the last bulletin we set you this ethical dilemma to think about. What solutions did you find to the following and how could you use the [Code of conduct to help you](#)?

**A PhD student you supervised in the summer, has been asked to give a public lecture to an archaeology society. They have asked you if they can include images of high status objects excavated at the as yet unpublished local site, in order to illustrate their research. The images are their own**

**and there is no non-disclosure agreement, but there are active looters known to be working in the area so information has not been publicly released. They are keen for your advice. How can the Code help you to explain how they can balance protecting the site with sharing the results of their research and disseminating knowledge to the community?**

The *Code of conduct* can support you in your decision making in several areas. For example, the preamble to the *Code of conduct* says 'The fuller understanding of our past provided by archaeology is part of society's common heritage and it should be available to everyone'.

Principle 1.2 requires a member to be mindful of their duties to society and says that '...when applying their judgement to balance differing demands they shall give due regard to their fundamental responsibility to the interests of the public'.

Principle 2 says that members have 'responsibility for the conservation of the historic environment'.

Principle 4.6 expects that 'A member shall accept the responsibility of informing the public of the purpose and results of their work .... (within limitations or by considerations of...the wellbeing of the site) and for information for dispersal to the general public.'
