7. Future activities

Activities for 2024 – 2025 were discussed. Ideas included:

Series of talks led by invited experts from a range of international organisations e.g.
International Financial Institutions, ICOMOS, International Scientific Committee on
Archaeological Heritage Management (ICAHM) and other International Scientific Committees
of ICOMOS, International Council on Museums (ICOM), International Centre for the Study of
the Preservation and Restoration of Cultural Property (ICCROM), International Committee for
the Conservation of the Industrial Heritage (TICCIH), Blue Shield International etc. to set out
best practices.

Talks may consider topics including:

- How is CIfA regarded overseas.
- How archaeology is being addressed in universities.
- How archaeology engagement is occurring with public.
- Latest innovative research agendas.
- Roles of commercial archaeology.
- Developing roles of archaeology for cultural engagement.
- How archaeology is being used for supporting UN's SDGs.
- Useful future roles for CIfA overseas sharing/mentoring/training/hosting meetings
- What can we learn in UK from overseas best practice.

Presentation from UK Government and/or BC (not HE/HS/Cadw etc.?) related to archaeology overseas.

- Present and emerging new policies.
- Funding and careers.
- Potential roles of CIfA and membership to overseas embassies and trade delegations.
- Roles for supporting social development and support to implementing SDGs.
- Cultural Heritage Protection Fund perhaps ask for presentation from British Council?

Archaeological participation in Climate Change agendas (COP29/30)

- Roles of CIfA for supporting natural and conflict disaster recovery undertakings
- Roles for CIfA in supporting education programmes and British overseas tourism

• Expedition workshops

The committee discussed other proposed activities, including practical training/ lectures/ workshops for colleagues who want to work overseas and/or go on an expedition. Could be an afternoon or weekend. Could be free or paid. Could be remote, desk-based or hand-on. Perhaps best organised in partnership with e.g. RGS-IBG who are highly experienced. Many of the expeditions they sponsor and support with training often address cultural and heritage research topics. They do a lot on ethics, permissions, relationship with people and the environment, dos and don'ts, food, health, and safety, practical vehicle maintenance etc.

The discussion noted that expedition workshops may be difficult as they can't cover cultural behaviours for all areas and need to be framed carefully. Particular aspects, e.g. H&S, personal experience of working abroad, mental health, personal security and coping strategies may form the basis of workshops.

Should remain non-country specific but provide general advice be a pointer to looking things up for yourself. With some case studies/lived experience. Explaining what the work may entail.

May seek to poll attendees on what they are concerned about or would like advice on.

Start with a lunchtime talk? Record it. If successful, then perhaps consider doing longer workshop at CIfA Annual Conference 2025 if selected conference theme is relevant.
