1. Revised SIG aims and name

- Email sent out to SIG members with proposed changes. Deadline changed to beginning
 of August, to allow more time for feedback.
- Proposed changes will now be submitted to the CIfA Board at their 13th September meeting, rather than July as originally planned.
- Discussion about new SIG name Community Archaeologists is the suggestion that's been sent out to members, but general preference amongst committee present for Community Archaeology.

2. Vacant committee post

- Two vacant posts have been advertised on recent JIST bulletins. A couple of people
 expressed interest during the CIfA conference see if they are still interested if no other
 interest.

3. Sector updates

- Discussion about Historic England's heritage wellbeing working group, of which the CBA are also a part. Might be useful to link with them in future.

MOLA have gone back to NLHF to get a project extension, to allow time for a series of pilot projects to be run. These will be delivered by the project partners, along with further training.
